

# RYOBI NATION PALLET PROJECT CHALLENGE

## TERMS AND CONDITIONS

NO PURCHASE NECESSARY. A purchase will not improve your chance of winning. The RYOBI Nation Pallet Challenge is open to legal residents of the United States and the District of Columbia, 18 years of age or older. Employees of the Sponsors, Techtronic Industries Power Equipment, ("TIPE") and The Home Depot U.S.A., Inc., and their immediate families are not eligible to enter. Bloggers that have previously worked with Sponsor over the past three (3) years are also not eligible to enter. RYOBI Nation Pallet Challenge entry period starts at 12:01 a.m. EST Monday, August 01 2016 and ends at midnight EST on Wednesday August 31, 2016.

To be eligible for RYOBI Nation Pallet Challenge, entries must be submitted before midnight EST on Wednesday, August 31, 2016. All entries must be received during RYOBI Nation Pallet Challenge entry period to be eligible for consideration. To enter, you must (a) follow the directions of the respective RYOBI Nation Pallet Challenge as outlined on the RYOBI website ([www.ryobitools.com](http://www.ryobitools.com)), (b) share a photo of your respective, completed DIY project created out of (1) single pallet via an authorized social media channel (i.e. Facebook, Twitter, or Instagram), and (d) use the following hashtag: #RYOBINationRocks and #RYOBIPalletChallenge or (e) upload your project to RYOBI Nation using the form on the website (<https://www.ryobitools.com/nation/projects/new>). The criteria used to select the winners will include but not be limited to social sharing, number of "likes" or "favorites," overall popularity, creativity, demonstrated craftsmanship in the photo, etc. Upon submission, entries shall become the property of TIPE. Sponsors reserve the right to use your entry and any comments or images submitted in future marketing campaigns. Pictures submitted showing a product must feature the product's use or placement in accordance with all safety standards outlined in the respective operator's manual. The Sponsor reserves the right to disqualify any pictures from the contest and to select winners in its sole discretion.
