Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

Contest may only be entered in or from the 50 United States and the District of Columbia and entries originating from any other jurisdiction are not eligible for entry. This Contest is governed exclusively by the laws of the United States. You are not authorized to participate in the Contest if you are not located within the 50 United States or the District of Columbia.

How to Enter.** During the Contest Period (defined below), take a photo ("Photo") or video ("Video") and/or write a caption in 140 characters or less ("Caption") which describes your "dorm room" ("Theme") or the dorm room of someone you know and upload the Photo/Video/Caption with the hashtag #RYOBIdorm via one of the following methods:
 - (i) Via Facebook: Go to Sponsor's page, located at www.facebook.com/ryobitoolsusa/ ("Sponsor's Page"), and follow the links and instructions to enter. Upload the Photo/Video/Caption with the hashtags #RYOBIdorm and #contest to Sponsor's Page and click the "post" button. You must have a Facebook account to enter via this method. If you do not have a Facebook account, you can create one by visiting www.facebook.com. Facebook accounts are free.
 - (ii) **Via Instagram:** Log onto your Instagram account and post the Photo/Video/Caption with the hashtags #RYOBIdorm and #contest and tag Sponsor @RYOBIpowertools. You must make sure your photos are public and be a follower of @ryobipowertools to be eligible to enter this Contest via Instagram. You must have an Instagram app and account to enter via this method.
